Evaluation Brief | May 2024

INTRODUCTION

Parks After Dark (PAD) is a Los Angeles County initiative led by the Department of Parks and Recreation (DPR), in partnership with other County departments and community-based organizations. PAD has been operating since 2010 in Los Angeles County areas with high levels of violence, obesity, and economic hardship. Parks serve as a community hub, connecting attendees to unique programming and health and social services to improve their well-being.

DPR introduced two new goals and two new strategic priorities in 2023, including a focus on positive youth development, targeted senior engagement, inclusion of community members in program design, and community-driven safety approaches.

PAD Goals

- Decrease community violence and INCREASE SAFETY
- Pacilitate CROSS-SECTOR COLLABORATION in park communities and countywide
- Increase SOCIAL COHESION AND FAMILY AND COMMUNITY WELL-BEING
- Increase access to FREE RECREATIONAL PROGRAMMING, AND HEALTH AND SOCIAL SERVICES that reflect the interests and needs of communities served
- Increase physical activity and DECREASE CHRONIC DISEASE RISK
- Contribute to POSITIVE YOUTH DEVELOPMENT
- Promote SENIOR CONNECTEDNESS



PARTICIPANTS

PAD was hosted at **34 DPR parks** between June and August 2023, offering programming on Thursday, Friday, and Saturday nights for eight weeks.



SPOTLIGHT: PAD PARK STAFF

As emphasized in key informant interviews, PAD park staff are seen as critical to the success of PAD. Staff are dedicated to serving their community through PAD, tailoring events to meet attendees' needs. Park staff are seen as a facilitator to feelings of safety at PAD and often work to build trust and rapport with regular PAD attendees. PAD partners described park staff as having a "whatever it takes mindset" when it comes to PAD; staff often step out of their traditionally assigned roles to contribute.

SPOTLIGHT: COMMUNITY INTERVENTION WORKERS AND THE SAFE PASSAGES INITIATIVE (SOUTH AGENCY)

The Safe Passages Initiative, funded by DPH's Office of Violence Prevention, contracts with community-based organizations to hire gang interventionists who ensure youth, teens, and families can get to and from PAD parks safely and can enjoy PAD and other park programming.

Interventionists work to engage gang-impacted youth in PAD, provide crisis intervention services at the parks as needed, and work in partnership with park staff, law enforcement, and communities to monitor and ensure safety. Recognizing that not all communities are comfortable with the presence of deputy sheriffs, intervention workers can help to facilitate feelings of safety. Intervention workers often have a deep understanding of community dynamics and events and work collaboratively with PAD staff to anticipate any potential safety concerns.



SPOTLIGHT: YOUTH AT WORK PROGRAM

The Youth at Work program offers individuals 14–24 years old with paid work experience and soft skills training. DPR has served as a host site for the program and from July 2022–June 2023, over 370 youth worker placements occurred across the 34 PAD parks. Since the program's inception, over 100 youth have obtained part-time employment with DPR.



"We've had a lot of people actually write into our department just saying how much this has saved their teenager from going in the wrong direction, or parents even talking about how they didn't have finances to take their kids on vacation for the summer ... PAD was the place that they took their kids for all the fun over the summer."

Select recommendations based on 2023 PAD evaluation findings include:

- Promote safety at PAD parks through continued engagement of deputy sheriffs and expanded involvement of community intervention workers.
- Expand physical activity offerings to appeal to a variety of age groups and interests, in order to maximize the impact on chronic disease.
- Ensure staffing support for PAD by strategically planning in advance and exploring opportunities for youth employment and community volunteers.
- Continue tailoring of programs to meet unique PAD park community needs.

SPOTLIGHT: SPRING AND WINTER PROGRAMMING

In 2022, PAD introduced one-day spring and winter PAD events, which were themed around holidays and offered a variety of activities for all ages. These events have been well received by attendees and have expanded PAD's reach.
